THE HIGHLIGHTS OF THE ASRF'S 15^{TH} BUSINESS MEETING

The 15th Business Meeting of the African Studies and Research Forum (ASRF) was held on November 22, 2009, in Cape Coast, Ghana, as part of the 27th Annual Conference of the Association of Third World Studies. The meeting was attended by several members of the organization. George Kieh, the President of the ASRF, presided over the meeting. At the end of the meeting, the following major decisions were taken:

The First ASRF Conference: The First ASRF Conference, which was slated to be held at a venue in the United States in the spring 2010, was postponed.

The Second ASRF Conference: The Second ASRF Conference, which was slated to be held in an African country in 2011, was also postponed.

Future Business Meetings: The organization will continue to hold its annual "Business Meetings" during the annual conference of the Association of Third World Studies, until decided otherwise by the Forum, the highest decision-making body of the ASRF.

The Membership Fees: The membership fees were revised as follow: 1)Regular membership(resident in the United States and other developed countries): \$50.00 annually; 2)Regular membership(resident in Africa and other Third World regions): \$30.00 annually; 3) Student membership(resident in the United States and other developed countries): \$25.00 per annum; 4) Student membership(resident in Africa and other Third World regions): \$15.00 per annum; 5) Life membership(resident in the United States and other developed regions): \$400.00; and 6) Life membership(resident in Africa and other Third World regions): \$150.00.

The Application for Tax-exempt Status: It was decided that the organization should continue the process of applying for tax-exempt status from the United States' Internal Revenue Service. When granted, the tax-exempt status would enable the organization to apply for grants, for members to deduct their annual membership dues from their taxes, and for the organization to solicit and receive tax deductible contributions.

Mueni wa Muiu, Assistant Professor of Political Science at Winston Salem State University, North Carolina, was the recipient of the "ASRF's Excellence in Research Award, 2008-2009."
