THE "PLAN OF ACTION FOR 2008-2010"

The Forum, the highest decision-making organ of the ASRF, has approved the "Plan of Action for 2008-2010," which was submitted by the new administration: The "Plan" has the following major elements:

The Formalization and Institutionalization of ASRF: The ASRF has moved towards institutionalizing and formalizing its presence and operations in order to have an effective and visible presence in addressing matters germane to the development of Africa both at academic, policy and practical levels. Towards this end, the leadership has taken steps to formalize the organization along with producing documents that guide its operations. Among these are: 1) The registration of ASRF as a not-for-profit organization in the state of Michigan; and 2) The application for tax exempt status from the Internal Revenue Service of the United States. This will allow members to get tax deduction for the payment of their annual membership dues, as well as for making donations to the organization.

The "Initiatives"

"The Female Members' Professional Development Support Initiative:" This is designed to employ the reservoir of knowledge in the ASRF in order to provide advice and counsel to the female members of the African Studies and Research Forum on

matters relating to their professional development—job search, publication (preparation and issues of access), tenure, and promotion, etc.

"The Members' Publication Support Initiative:" This would entail the provision of advice and counsel to the members of the ASRF on the various issues related to publication, including manuscript preparation for books, monographs, book chapter and journal articles, publication outlets for books, monographs and journal articles, and the related issue of access to these publication outlets.

"The Members' Tenure and Promotion Support Initiative:" This would entail the provision of advice and counsel to the members of the ASRF, who are applying for tenure and promotion at their respective institutions.

"The Partnerships with African Universities and Research Institutes Initiative:" The thrust of this activity is to develop a relationship with various universities and research institutes across Africa that would focus on undertaking various joint and other activities. This 'Initiative' seeks to establish partnerships with ten (10) African universities—two each in Central, Eastern, Northern, Southern, and West Africa—and four research institutes over the period 2008-2010...

"The Summer Institute for Graduate Students at African Universities Initiative:" Under this "Initiative," the ASRF will organize and conduct an "Institute" each summer focusing either on a particular discipline or a cluster of disciplines for selected graduate students at various African universities. The venue of the "Institute" will rotate each year among the various regions of the continent.

Publications: The organization has decided to continue one existing publication and to establish three new ones. The existing publication is "The ASRF Book Series." Under the "Series," the ASRF will continue to commission the publication of books by its members. The Publication and Research Committee has formulated and promulgated guidelines for the submission of book proposals by members. The three new publications are: "The ASRF Monograph Series" and the Journal of African Studies and Research. "The Monograph Series" will serve as an outlet for the publication of manuscripts that are longer than journal articles, but shorter in length than a book manuscript. Also, the Publication and Research Committee has developed and published guidelines for "The Monograph Series." The journal will be an online(e-journal) publication, which will be managed by an editorial board to be headed by the ASRF's Director of Research and Publication. A quarterly newsletter will be published. Its purpose would be to disseminate information about sundry issues—news about members' publications, tenure, promotion, and new positions, teaching, research and publication opportunities, among others.
